1. INTRODUCTION

- 1.1 The Singapore Examinations and Assessment Board (SEAB), together with the Ministry of Education, Singapore (MOE) and Cambridge International Education, are the joint examining authorities for the Singapore-Cambridge GCE-Level examinations. The examinations are administered by SEAB.
- 1.2 This document stipulates the regulations and the administrative instructions for registration for the GCE-N(T), GCE-N(A), GCE-O and GCE- A-level examinations.
- 1.3 All materials submitted for examination purposes (e.g. examination scripts) are deemed as examination materials and their rights shall be assigned to SEAB.
- 1.4 Before registering for any examination subject(s), you are advised to read the information in this document thoroughly. By registering for the examinations offered by SEAB,
 - 1.4.1 you agree to comply with all examination instructions and regulations stipulated in this booklet and other examination documents issued by SEAB, and accept the possible consequences if you breach them.
 - 1.4.2 you shall assign your rights in the examination materials to SEAB, and acknowledge that SEAB may collect, use and disclose your data for the purpose of carrying out all functions and duties of the SEAB under the SEAB Act 2003.
- 1.5 SEAB may issue additional administrative or procedural instructions for the conduct of specific papers (e.g., written papers, oral, and practical papers). You will be informed of the new or updated instructions through email notifications to your registered email address. The new or updated instructions will also be published on [SEAB's website](#). Unless stated otherwise, they will form part of the examination rules and regulations for the examination year, effective from the date of announcement. You should check SEAB's website for any updates to the instructions, prior to your examinations.
- 1.6 The national examination question papers are copyrighted. You are not allowed to post online, publish or reproduce the national examination question papers in any form without permission from SEAB. SEAB will take all necessary actions, including penalties against candidates if there are any copyright infringements.
- 1.7 No part of this document, whether image, text or otherwise, may be copied, reproduced, published, adapted, modified, distributed, transmitted, communicated and/or stored in any form or by any means without the prior written permission of SEAB.

2. REGISTRATION

2.1 REGISTRATION PERIOD AND ELIGIBILITY

You can register for the 2024 Singapore-Cambridge GCE N(T)-, N(A)-, O- and/or A-Level examination(s) through SEAB's [Candidates Portal](#) from **Thursday, 4 April 2024, 9.00am to Wednesday, 24 April 2024, 11.00 pm.**

Regular updates on registration, examination schedules and important dates will be published on [SEAB's website](#). You are advised to check SEAB's website regularly.

The minimum age requirements and maximum number of subjects allowed for registration for each examination level are indicated below:

Examination Level	Minimum Age Required as at 1 st January 2024	Maximum Number of Subjects Allowed
GCE N(A)- and N(T)- Level	15	8
GCE O-Level	15	9
GCE A-Level	17	<ul style="list-style-type: none">• 5 H1 subjects and 3 H2 subjects; or• 3 H1 subjects and 4 H2 subjects



School candidates who are enrolled in Government/ Government-Aided/ Independent/ Specialised schools cannot register as private candidates. If you are a school candidate, your registration as a private candidate will be invalidated and any paid examinations fees will not be refunded.

You are allowed to register for more than one GCE-Level examinations (e.g. GCE N(A)-Level and O-Level examinations) within the same examination year (e.g. 2024 examination year). However, you cannot register for the GCE-level examinations and admissions tests i.e. Admission Exercise for International Students (AEIS) and School Placement Exercise for Returning Singaporeans – Secondary (SPERS-Sec) in the same examination year.

2.2 EXAMINATION SUBJECTS

Science Subjects with Practical components

If you are registering for a Science subject with a practical paper, you

- Must have sat the same Science subject(s) previously as a school or private candidate **OR**
- are currently attending or will be attending a course of instruction in Science Practical at any institute/school. You must complete the course of instruction in Science practical before the date of your practical paper.

You are required to declare that you have fulfilled the above requirements at the point of registration. Registration for the subject may be cancelled without a refund of the examination fees if a false declaration is made.

Mother Tongue Language Subjects

- (i) You may sit for the GCE O-Level and/or A-Level Mother Tongue Language (MTL) subjects during the Mid-Year and/or Year-End examinations. You will need to select **either** the Mid-Year **or** Year-End examinations during the registration period.
- (ii) There is no re-sitting for the GCE O-level and A-level Mother Tongue Oral and Listening Comprehension examinations. Candidates who are eligible may register to re-sit Year-End Mother Tongue written papers after the release of the Mid-Year examination results.
- (iii) You will be advised on the Year-End MTL examination registration procedures and timelines when the Mid-Year MTL examination results are released.
- (iv) You will receive a grade for each subject which you sat for in the examination during the release of the GCE-level examination results. The results would not show a breakdown by paper level for the written papers. If you sat for your MTL subject in both the Mid-Year and Year-End examinations, the better result of the two sittings will be reflected on your certificate, provided you obtained an overall pass in your MTL subject. Prior to the release of your certificate, your Mid-Year MTL results will only be reflected on the Candidates Portal.

2.2.1 You may refer to the list of subjects offered for the GCE N(T)-, N(A)-, O- and A-Level examinations, as well as the subjects which cannot be taken together in [Annex A](#). Any pre-requisite requirements will be highlighted with the subjects. Details of additional examination requirements for each subject are found in the syllabus documents published on [SEAB's website](#).

2.2.2 Please note that the following subjects are not offered to private candidates.

- Subjects with coursework components (e.g Art and Design & Technology)
- A-level H3 subjects
- O-level and A-level Mother Tongue Language Syllabus B (MTL Syllabus B)

Singapore Citizens and Permanent Residents who wish to register for O-level and A-level MTL Syllabus B will need to write to [SEAB](#) to seek approval, latest by **8 April 2024**.

2.2.3 A subject may not be offered if it has less than 20 registered candidates in a particular examination year. In such situation, you will be informed, and you may choose another subject. Refund(s) will be given for the affected subject if you choose not to register for a replacement subject.



- **It is compulsory for you to sit for all registered components of a subject**, such as the Oral, Listening Comprehension, Practical and Written papers. This is regardless of whether you had sat for those papers in previous years.

If you did not sit for any one or more components, you will be recorded as 'Absent' for the subject, and you will not receive an examination grade, unless you have been granted exemption by SEAB for the component(s).

- If you sit for the examinations of duplicate subjects* in the same examination year or across different examination years, **only one of the duplicate subject results can be used in the aggregate computation for progression.**

* Duplicate subjects refer to:

- The same subjects offered at different examination levels. An example is GCE N(A)-Level Mathematics Syllabus A and GCE O-level Mathematics.
- Different subjects offered at different examination levels that have contents overlapping. An example is GCE N(T)-Level Science Syllabus T and GCE N(A)-Level Science (Physics, Chemistry).

2.3 EXAMINATION FEES

- 2.3.1 The examination fees payable will be based on your citizenship status at the point of registration. Please make sure that you have indicated the correct citizenship status during registration. There will be no refund of your examination fees if you have changed your citizenship status after you have submitted your registration.
- 2.3.2 The fee for each subject may differ depending on the subjects registered for. Please refer to [Annex A](#) for the respective fees for each subject for this examination year.
- 2.3.3 All examination fees are inclusive of Goods and Services Tax (GST) at the prevailing rate. Examination fees are not transferable from one examination year to another, or from one candidate to another.
- 2.3.4 Please pay for your examination fees via credit/debit card or PayNow in the Candidates Portal by the registration deadline of Wednesday, **24 April 2024, 11.00pm**. **You will not be registered for the examinations if you did not make payment by the deadline or if your payment is not successful.**

Funds in your Edusave account and Post-Secondary Education Account (PSEA) cannot be used to pay for your examination fees.

2.4 AMENDMENTS TO REGISTERED SUBJECTS

- 2.4.1 Please check your registration details and the examination subjects which you are registering for carefully before submitting them online. Any changes thereafter will incur an amendment fee.
- 2.4.2 You may refer to the subject amendment procedures and fees below:

3 WITHDRAWAL AND REFUND

3.1 WITHDRAWAL FROM THE ENTIRE EXAMINATION

3.1.1 An application for withdrawal from the entire examination must be submitted via the [Candidates Portal](#) by **2 September 2024, 11.00pm**. Any withdrawal request after this date will not be considered.



- You will NOT receive any results for any subjects or components of subjects that you have sat for.
- Your results will be invalidated if the examination results have already been released to you (For example, the Mid-Year written examination results that are released in August annually).

3.2 REFUND

3.2.1 A 50% refund of the subject fee(s) paid (inclusive of GST), for the GCE N(T)-/N(A)-/O-/A- Level examinations, may be provided if:

- Your withdrawal request is submitted to SEAB by **21 June 2024, 11.00 pm and**
- You have not sat for any component of the registered subject that you are withdrawing from.

You will receive the refund approximately one month after your withdrawal request is approved by SEAB. **Please note that any late registration fee and subject amendment fees are non-refundable.**

3.3 APPLICATION FOR ADMISSION TO TERTIARY INSTITUTIONS

3.3.1 If you are in the process of applying for admission to tertiary institutions but wish to re-sit the GCE O- or A-Level examinations while pending acceptance, you should proceed to register during the registration period from **Thursday, 4 April 2024, 9:00am to Wednesday, 24 April 2024, 11.00pm** to avoid any late registration fees.

3.3.2 If you subsequently gain admission to the tertiary institutions, you may submit a withdrawal request and apply for a refund (less subjects which you had sat for) of the examination fees with the supporting documents confirming your tertiary admission via the [Candidates Portal](#) by **Friday, 21 June 2024, 11:00pm**. Any request after the deadline will not be considered.

3.3.3 Please note the supporting documents confirming your tertiary admission must be issued during this examination year (i.e. 2024).

3.3.4 **There will be no refund of your examination fees if you submit your withdrawal request in the [Candidates Portal](#) after 21 June 2024, 11.00pm.**

4. ENTRY PROOF FOR EXAMINATION

4.1 DOWNLOADING OF ENTRY PROOF

4.1.1 The softcopy Entry Proof for your registered examination will be available in the Candidates Portal in mid-May 2024 (for Mid-Year MTL examination) and end-June 2024 (for Year-End examination). **You will be notified of the availability of the Entry Proof via an email sent to your registered email address.** You will be posted to different examination centres for the different Mode of Assessment (MOA) examinations ie. Oral, Science Practical, Written examinations. As such, it is important to check your Entry Proof before the examinations. Please ensure that you read the Candidates Portal user guide on how to download the Entry Proof in the Candidates Portal.

4.1.2 **You must bring along the hardcopy Entry Proof on the examination together with your NRIC/FIN, as it will be used to verify your attendance at the examination venue. An example of the Entry Proof is shown on the next page.**

Instructions to Candidates

- You are required to bring along this Entry Proof and your photo-identification document (e.g NRIC or Passport or Printed Copy of Digital Student Pass) bearing the identification number as stated on this Entry Proof when you report for the examination. You have to report to the examination centre at least 30 minutes before the commencement of the examination.
- If you are sitting for a Listening Comprehension (LC) examination, you must be seated at your assigned seat in the examination room by the start time of the paper that is indicated in this Entry Proof. Attendance will be taken and examination instructions will be announced at the start time. The broadcast of the LC examination will begin 30 minutes after the start time.
- If you are sitting for a Science Practical Examination, you will be notified of your examination schedule, at least 7 days before the examination, by email or post. Contact SEAB at www.seab.gov.sg/contactus if you did not receive your examination schedule before the examination. For subjects where calculators/dictionaries are allowed, you must ensure that your calculators/dictionaries are listed in the "Approved Calculator List"/ "Approved Dictionary List". The lists can be found online at www.seab.gov.sg. It is important that you read and be familiar with the "Instructions For Candidates Affected By A Major Disruption" document which can be found online at www.seab.gov.sg.

To Note:

- Candidates sitting the GCE N(A), N(T), O or/and A-Level Examinations are required to observe and comply with all instructions and regulations governing the examinations. These are stated in the "Examination Rules and Regulations for Private Candidates" document. The instruction document can be found online at www.seab.gov.sg. Candidates must also observe and comply with any additional instructions and procedures that SEAB may announce nearer to the examination dates. Candidates should refer to SEAB website at www.seab.gov.sg for updates of instructions and procedures before sitting for the examination.
- The possession of any electronic/communication devices (e.g. mobile phones, tablets)/computerised aids (e.g. computerised wrist watches) is strictly not allowed in the examination premises (e.g. examination room/hall, quarantine room, waiting room). Candidates who are found with these devices may be prohibited from taking the examination, expelled from the examination room, refused entry for subsequent papers, have their results terminated or a grade penalty and/or be banned from registering for the examinations in future years.

4.2 CHANGE OF PERSONAL PARTICULARS

- 4.2.1 You can make the changes to your residential address, email address and other personal particulars (except for NRIC/FIN/passport no, nationality and citizenship) in the Candidates Portal using the “**Edit Particulars**” function. You can refer to the Candidates Portal user guide on how to change your particulars using this function.
- 4.2.2 **As we will send important updates via email, please provide a valid email address at the point of registration, and check your email regularly so that you do not miss any important updates regarding your examination.** If you decide to change your registered email address, please make the changes in the Candidates Portal using the Edit particulars function.
- 4.2.3 Your assigned examination centre will be based on your residential address. It is important to provide the **correct residential address** that you will be residing at during the examination period. **Any request for reposting to another examination centre due to change of residential address will not be allowed after 31 May 2024 (for posting for year-end papers).**
- 4.2.4 For the purpose of results release and posting of the hardcopy examination certificates, we will allow for a one-time change of the registered residential address past 31 May 2024 but before these deadlines:
- 29 November 2024 for GCE N(T)/N(A)-Level examination,
 - 27 December 2024 for GCE O-Level examination, and
 - 7 February 2025 for GCE A-Level examination.

Should your examination certificate be delivered to your former residential address because the change in your registered residential address was not made in time, you will need to make plans to retrieve your examination certificate from your former residential address. There will be no reprint of the examination certificates.

Candidates who are non-Singpass users will have to write to SEAB to obtain a copy of their digitised examination results. Candidates who are Singpass users can login to My SkillsFuture portal to retrieve their results online.

5. ACCESS ARRANGEMENTS

Access Arrangements (AA) are examination arrangements granted to candidates with specific learning and physical needs, to enable them to sit the national examinations without compromising the assessment objectives. These arrangements are not intended to give the candidates an unfair advantage over other candidates taking the same examination.

If you have specific learning and physical needs **diagnosed before** the examinations, you may apply for AA by following the instructions below.

5.1 APPLICATION FOR ACCESS ARRANGEMENTS



- Please apply for AA by **29 April 2024, 11.00pm** via the [Candidates Portal](#). Please submit AA applications **only after** you have registered successfully for your examinations.
- Late applications may not be accepted or approved due to insufficient time for review.
- If the type of arrangements cannot be found in the Candidates Portal, or you require an examination room on the ground floor due to a medical condition please contact us via email at SEAB_CS_Admin@seab.gov.sg for further assistance before **29 April 2024, 11.00pm**.

5.1.1 The outcome of your AA application will be released to you via the [Candidates Portal](#).

For AA applications submitted by the specific deadline, the AA outcome will be available by the following months:

- May 2024 for the Mid-Year MTL examinations
- June 2024 for the Year-End examinations

You will receive an email notification informing you to download the AA outcome letter. Please also check your email’s “junk mail” folder as our email notification might be channelled to this folder.

- 5.1.2 You must download the AA outcome from the [Candidates Portal](#) and present the AA outcome letter to the examination personnel before the start of your examination(s), so that they can verify the AA granted by SEAB.
- 5.1.3 To withdraw from any AA that was granted, please submit the withdrawal via email to SEAB_CS_Admin@seab.gov.sg at least five working days before the date of the examination requiring the AA.
- 5.1.4 **SEAB will not reinstate the provision of AA once the request for withdrawal has been approved by SEAB.** If your withdrawal application is submitted late, the application may not be accepted or approved in time. You may still be considered to have made use of the approved AA during the national examinations and your results and examination certificate will correspondingly be annotated. Please refer to 5.2 for more information.

5.2 ANNOTATION ON RESULTS

Types of Access Arrangements with Annotation

Your examination results will be annotated for the following AA:

- Extra time allowance (including preparation time for oral examination);
- Exemption from satisfying the full range of assessment objectives in a subject (e.g. exemption from oral, listening comprehension etc);
- Modification of examination papers;
- Use of word processor facilities and other computer aids;
- Use of Reader or Scribe; and
- Practical assistance in areas such as handling of apparatus during the practical examinations, using instruments or graph plotting.

Types of Annotation Symbols

There are three symbols. The explanation for the symbols are as follows:

- **Exemption Symbol (#)**
'The candidate was exempted from satisfying the full range of assessment objectives in the papers sat for this subject.'
- **Access Arrangement Symbol (+)**
'The candidate sat the paper under access arrangements.'
- **E* Symbol**
'The candidate was exempted from the Oral and/or Listening Comprehension component due to valid reasons.'

- 5.2.1 SEAB annotates a candidate's results only when there are significant modifications for an examination. This is to indicate factually that the candidate had taken the examination under conditions that are different from the standard prescribed testing conditions, and it is done to uphold the integrity of the examination system.

SEAB will not reveal the details regarding the non-standardised conditions, even if there are requests for them.
